Auction Raffle Rules and Disclosures
March 2018

#### Term of Raffle

The raffle will begin on March 8, 2018. Tickets will be available for purchase before and at the St. Agatha School Auction & Gala taking place on March 24, 2018 at the Venezia Restaurant in Boston, MA (the "Auction & Gala"). The School will stop selling tickets when the Live Auction begins or when the 299<sup>th</sup> ticket is sold, whichever occurs first. The last ticket will be sold in the Live Auction.

#### Raffle Drawing

The winning ticket will be drawn at the Auction & Gala, immediately following the conclusion of the Live Auction. The winner does not need to be present to win. The holder of the winning ticket, if not present, will be notified by the phone number or e-mail address provided on his or her Raffle Ticket Order Form.

#### Prize Details

The winner will receive a choice of a \$5,000 tuition credit at St. Agatha School for the 2018-2019 school year <u>or</u> a \$5,000 cash prize. The tuition credit is not applicable to costs, fees or payments outside of tuition. All raffle proceeds, less the cost of prizes, will benefit St. Agatha School.

#### Eligibility

The raffle is open only to legal U.S. residents who are 18 years of age or older at the time of entry. Faculty and staff of St. Agatha School that have not been directly involved in the promotion or operation of this raffle are eligible to participate. The sale of tickets alone does not constitute promotion and operation of this raffle.

#### To Enter

No more than 300 tickets will be sold at a cost of \$50 each, and a minimum of 110 tickets must be sold in order for the raffle to take place. If 110 tickets are not sold, the \$50 ticket price will be refunded to the purchaser. Except for tickets purchased at the Auction & Gala, all ticket purchases must be made by sending the completed Raffle Ticket Order Form with your payment to the School Office. Numbered hardcopy tickets will be delivered to you via the method chosen on the Raffle Ticket Order Form. There is no limit to the number of tickets an individual may purchase up to 300. Odds of winning are dependent on the number of total tickets sold. The raffle ticket price is not tax deductible as a charitable contribution. Please note that depositing any raffle ticket in the mail is a violation of federal law and may lead to criminal penalties.

#### Subject to Tax Regulations

Prizes awarded under this raffle are subject to all applicable federal tax regulations, including, but not limited to, applicable IRS reporting and withholding requirements. Taxes on prize winnings are the sole responsibility of the winner, and prize winnings are deemed ordinary income to the recipient by the IRS. The winner should consult with his/her personal tax advisor regarding the prize winnings. St. Agatha School may require the winner to complete and submit certain documentation required under federal or state tax regulations as a condition of receiving the prize. Failure to timely complete, sign and return any such documentation may result in the winner's disqualification and the forfeiture of his/her interest in the prize.

#### **Transferability**

Tickets and prizes are not transferable, except that the tuition credit prize may be transferred in its entirety (and not in part) upon written notice to St. Agatha School sent to the attention of Mrs. Joan Brown no later than July 1, 2018, and provided that the winner remains solely responsible for the payment of all taxes on the value of the prize, including, but not limited to, income taxes.

#### Prize Delivery/Forfeiture

The winner must decide between the tuition credit prize and the cash prize, in writing, by April 27, 2018. Failure to do so will result in forfeiture of the cash prize. The winner is solely responsible for providing accurate contact information on the Raffle Ticket Order Form.

If the winner chooses the tuition credit prize by the April 27th deadline or fails to timely make an election so that the prize defaults to the tuition credit in accordance with the preceding paragraph, and the winner notifies St. Agatha School in writing by June 1, 2018 that the student beneficiary of the prize will not be returning to the school for the 2018-2019 school year, then the winner can convert the tuition credit prize to the cash prize. After June 1, 2018, the tuition credit prize cannot be converted to the cash prize and the raffle prize will be forfeited altogether if the student beneficiary does not return to St. Agatha School for the 2018-2019 school year.

The tuition credit prize may be used for any aged/grade child at St. Agatha School, including new students starting in September 2018. All admission policies/criteria apply. The tuition credit is nonrefundable if the student to which it is applied does not complete the school year for any reason.

Should the winner fail to designate a St. Agatha School student billing account on or before July 1, 2018, the winner forfeits the prize. If the prize is forfeited, the prize will be forfeited permanently and will not be awarded to another student.
